FCE Diamond Jubilee ~ 2011 National Conference

FCE was founded in June of 1936 during the third ACWW Triennial conference held in Washington D. C. In the early 1900's the Department of Agriculture recognized a need for a national program to help both farmers and rural women. FCE was the driving force in providing rural United States women with education in basic life skills. Today, with more readily accessible education, FCE is directing its concerns to families and communities. We invite you to the 2011 annual FCE Conference to celebrate 75 years of "*Connecting Families & Communities through Education, Leadership & Action*".

The Conference will be held at the Ramada Plaza in Northglenn CO, July 14-17, 2011. We are pleased to announce that the cost this year has been lowered to \$125 per day or \$345 for the full conference. If you purchase the Friday one day registration, the Thursday evening opening ceremonies are included. Five (5) meals are included in the registration fee. We have also negotiated a very reasonable hotel rate. The hotel is \$79 / Max Quad (4) occupancy and includes 2 breakfasts. Additional breakfast's can be added for \$5 per person. There will be a lot of great educational material and programs presented at the National Conference. FCL Leadership training sessions will be held Friday and are a part of the conference registration, normally there is a charge of \$99 for the FCL Training. You can earn 61/2 hours toward your certificate. Have you already earned your certificate? Continue your education in Leadership with these workshops. There is always something to learn!

Presidents Day will be held on Thursday, July 14, with practice for the opening ceremony, presidents meeting, lunch and tour. The president's meeting is open to all who are registered. Thursday evening is the opening of conference with presentation of State Presidents and the National Board. The Annual Business meeting will be Friday morning and is open to all, only voting delegates may vote during the business meeting. FCL training is Friday afternoon, alternate sessions will be offered for those not attending FCL training. Saturday will have FCE Educational programs presented by National Board members and alternative sessions. Sunday there will be an Inspiration Breakfast and memorial service. The Awards lunch will be at noon followed by closing ceremonies. After lunch we will have several of our younger FCE members from various states doing presentations as "Future FCE Stars" at no registration cost to them. There will be a session for State officers to ask questions about their responsibilities and National programs. National FCE is again sponsoring a book collection for a local Children's hospital in Denver, bring your books to the registration desk.

There will be something for everyone. There will be at least 2 and in most cases 3 presentations to choose from at any given time during the conference to provide multiple options for members to find something of interest to them. BUT, much like when a party is over, now the real work begins for all of us! Now that we are settling in with a new Congress and in many cases new States Legislature, we need to think of the issues at hand. In a democracy we have the right and the responsibility to work toward change. If the democratic process is to function effectively, citizens must be well informed about issues, and must be willing to express their views and then to participate in the decision making process.

Our elected officials like to hear opinions from the home front, and they want to be kept informed of conditions in the districts they represent. They do not tire of hearing from constituents who have something to contribute to the welfare of the state or nation. Elected officials listen most closely to the people they represent. Keep your communication with your elected officials constant, consistent, and concise. To make the greatest impact, you need to remain in close contact with elected officials. And don't forget to thank them for their willingness to serve in what can be a thankless job.

You can read about current bills on the floor or in committee by going to <http://thomas.loc.gov/>. There you will find much of the information you need, as well as links to the House and Senate. This website was set up in the spirit of Thomas Jefferson, who stated many times that the people need to be informed about what their government was doing, and then speak up. "Educate and inform the whole mass of the people... They are the only sure reliance for the preservation of our liberty." Thomas Jefferson

Change can happen. It takes some effort, but even small changes can make a difference.

Charity Project by the Tennessee Association for Family and Community Education

For the past several years, the Conference Host Region has chosen a charity to fund at our annual State Conference in November. This year, 'A Soldiers Child', a non-profit organization supporting our military families, and, begun by a Murfreesboro citizen, was chosen. Our conference was held in Murfreesboro at the Embassy Suites, and Daryl Mackin, the founder of the organization came to our conference on Monday evening to show a short DVD and speak to our attendees. Public Policy What it is

Several members have asked “Why do we have a Vice President of Public Policy? What is the roll of public policy in FCE?” To answer those questions, we need to know what public policy is. There are ‘public policies’ and ‘public policy actions’.

Public policies are all those laws, regulations, rules of elected and appointed governmental bodies that impact our lives –i.e.: 1) *local* weed authority board determines/rules that land and property owners must control weeds on their property. 2) *state* laws have been set up that regulate highway speed, welfare recipients, state taxes, drinking age. 3) *national* legislation states rules for receiving Social Security, Federal Income tax, regulations concerning drugs and food etc.

FCE members use **public policy actions** to help influence or change public policy. These can be:

- Communicating with lawmakers
- Facilitating/coordinating candidate forums
- Signing/passing petitions in support or opposition to legislation or regulations
- Serving in elected position or appointed board position for a public entity
- Encouraging other groups to support your position (coalition work)
- Campaigning for an issue to be voted on (FCE groups may **NOT** campaign for a candidate according to 501 (c) 3 guidelines)
- Communicating your position to all forms of the media – telling about your position on a public policy issue and involving public policy actions. (This is different than providing publicity about your group to the media)

The VP of Public Policy has charge over the FCL program. FCL training is where members learn the skills necessary to effectively use public policy actions, as well as other leadership skills. FCE Programs are implemented in our communities through the use of those skills.

Get involved in the Public Policy process! You’ll be glad you did!

NATIONAL FCE NOMINATIONS for BOARD POSITIONS

National FCE is again looking for qualified candidates for positions on the NAFCE Board. Positions open for the 2011 election are President Elect, Vice President for Public Policy, Secretary, Central Region Public Policy Coordinator, Pacific Region Public Policy Coordinator, and Pacific Region Program Coordinator ~ to fill a 2 year unexpired term. Nominations for each position shall be mailed to each member of the FCE Nomination Committee and the Secretary with a postmark 60 days before the first day of conference, **Monday May 16**. The Nominating Committee Chairman is Betty Schalk, Central Region Public Policy Coordinator. Members are state presidents from the three (3) regions. Atlantic Region ~ Sheila Jackson, WV, Central Region Mary Jane Adams KS, Pacific Region Margaret Mai, AZ, Pacific Region Patricia Kubo, HI. Nominations forms are available from state presidents, members of the committee and from National FCE Headquarters. The addresses of the nominating committee and secretary will be included when a form is requested.

Qualifications for office are that each candidate shall be a member in good standing and shall have agreed in writing to the nomination. A candidate shall be serving or have previously served as an appointed or elected officer of her/his state affiliate or have served on the National FCE Board within the preceding eight years. A candidate shall have completed any term of office in the state affiliate or FCE by January 1 of the year following election at National FCE Conference. An officer may not resign from a presently held position in order to run for another FCE position. An individual appointed to fill a vacancy shall be eligible to run for an elected position. A candidate for President Elect shall have served on the FCE Board within the preceding eight years. A candidate for Vice President for Public Policy shall have served on the FCE Board within the preceding eight years and be experienced in this organization’s public policy program. A candidate for Secretary shall understand the importance of preserving the official records of FCE, have the ability to write accurate minutes, and provide a safe repository for official records. A candidate for Public Policy Coordinator shall be experienced in this organization’s public policy program. (NAFCE Bylaws, Article V, Section 2).
