The AK newsletter is always very informative and full of “happenings” from around the state.

Maryland – Maryland FCE does a good job in keeping the members abreast of ACWW and international news and the public policy issues that are pertinent for Maryland residents. At their annual conference members were asked to indicate what “101 Things to do With Your Family” poster activities they participate in. The most popular activities were playing cards, taking walks, reading, biking and swimming. *Contact National HQ for a poster with the complete 101 list.*

Michigan – The 2008 fall newsletter contained the complete list of MI State Board members and committee chairs. Having these lists available makes contacting any of those officers and chairs easy for all members. News from county and district meetings keeps everyone informed of what goes on around Michigan. To reduce costs, the MI FCE board has been reduced by two and the position of Membership Recorder has been eliminated.

Missouri – The Pleasant Center Club in Grundy County celebrated its 60th anniversary last May. Congratulations! Detailed reports were printed from district meetings. Contributors to the Missouri Foundation for FCE were publicized. This is a very viable foundation in Missouri. The list of district officers and committee chairs is published annually for members.

Nebraska – The Extraordinary Women celebration from 2008 was highlighted. This was a National FCE event for each state to have one woman recognized at the FCE National Conference in Burlington, VT. Honored at the Nebraska Conference were: Mary Lou Christensen, Kathaleen Mead and Gloria Meek. Gloria was selected as the national entry. Her family and friends were in Burlington to receive her posthumous recognition.

Hawaii – Hawaii is great at recognizing members for their achievements with photos and articles. Vice President Diane Hultman wrote an interesting article titled “What Does R&R Mean to You?” It could mean “rest and relaxation”, “respect and responsibility”, or “refreshed and rejuvenated”. Or all three, as her column explains about a Hilo Council get away camp.

Kansas – In the December 2008 issue of this newsletter, President Marcy Price had a report on events at National Conference in 2008 and a plug for the KAFCE bus trip to Portland, Oregon. The 2009 FCE and FCL lessons were described for the coming year. If a KS member finds her/his membership number within the newsletter, a prize awaits for letting Marcy know.

West Virginia – Members are proud of the \$20,000 Susan G. Komen for the Cure grant they received in 2008. This is used to provide mammograms for women ages 40 to 49 who are uninsured or underinsured and for breast cancer awareness education.

National FCE and the Entertainment Software Rating Board or ESRB have worked together since August 2006. ESRB has written articles for the FCE TODAY and has written a "letter of support" for our grant writing applications. ESRB provided National FCE with its rating system brochure for video and computer games which were distributed at National FCE Conferences. This brochure is available at their website www.esrb.org. It is a good compliment to the FCE Ratings/Information Symbols Bookmark. See page 6-3 to order. FCE's Professor Media recommends both items to parents for assistance in making informed decisions regarding these media sources.

The National Institute on Media and the Family, a conservative watchdog group that has criticized the game industry in the past, recently issued its annual video game report card. For the first time, the industry got nearly straight A's from the Institute.

"This year the industry has improved its ratings enforcement and given parents new tools when choosing the right video game for their child" said David Walsh, National Institute on Media and the Family president and founder. That's a significant step in the right direction. However, the group gave parents an 'incomplete' for not consistently using the information provided by the Entertainment Software Rating Board, EC-early childhood, E-everyone after age 6, E10+-everyone 10 and older, T-teen and M-mature, age 17 and older.

"Now that we parents have the information tools we need, we have to step up and do our jobs," Walsh said. "There are still too many kids playing M-rated games and too many kids playing for far too long."

COUNTRY-OF-ORIGIN LABELING

Consumers have heard of country-of-origin labeling for several years. There are pros and cons of the laws introduced in the 2002 and 2008 Farm Bills, but never the less, it is now law that most food products must have this labeling.

As of September 30, 2008, the following products are covered: *beef, lamb, pork, fish, chicken, fresh and frozen fruits and vegetables, peanuts, macadamia nuts, pecans, and ginseng.* The labeling in grocery stores can be by various methods including signs, placards, and stickers.

Restaurants, lunchrooms, cafeterias, and food stands are exempt from the requirements. Processed foods or “blended” foods, such as a pre-packaged mixed salad, are exempt. Stores can label foods not indicated in the law, as long as the labeling is truthful.

If you attended the Mid-Year Leadership Seminar in Washington D. C. in February 2003, you probably remember the introduction of COOL (Country of Origin Labeling) by Barry Carpenter from the USDA's Agricultural Marketing Service. This was one of those events when National FCE members were first to hear about this new government regulation effecting consumable agricultural products.

Dear FCE,

I've been an FCE Extension Unit and Home Demonstration member for 68 years. Due to health matters now at 89 years of age and living the distance from other members I should quit though I greatly don't want to. I gave obtained lots of good factors for my life and family and of helping others.

I joined in the summer of 1940 when I was 21. My husband's two sister-in-laws took me and paid my dues. The meeting was at a county school with a large attendance of members. They had invited young women and a number of teen age girls. A noon meal was prepared on a little kerosene stove and ovens. The menu included coated pork chops, baked carrots and some other side dishes and a pineapple upside down cake. I used to have the recipes.

We were the Happy Homemakers unit and meet in homes until we became a large group then we went to a county school house taking it over as a community center. We had a large number of young women with small children. As a rule we had 30 to 40 regular members. We were in the process of getting that school house in the Historical Association when the county decided to dispose of it, lots of the specialness of the community was lost. We went back to homes for our meetings until they built a Senior Center where some of the meetings are still held today.

By 1995 the Happy Homemakers had lost most of our members so we joined the Elk Creek Farmers of Thayer whose membership had also greatly decreased. We did a lot of community and county work, attended meetings in other counties and a lot of organizational work.

I lost my mother to whooping-cough when I was 6. My father was left with 7 children ages 3-15 but he kept us together. We lived on a farm and each had our work. My sister who was 9 and I knew cooking and house keeping which I took over fully at age 16. We 4 younger children were able to go to high school. My father's mother was a great help teaching us cooking, canning, sewing and on and on.

I was in 4-H for 6 years and having a very special leader I was fortunate and got to take tailoring lessons from a Home Economist. I have helped many others including my daughter who has become a beautiful sewer and homemaker, my daughter-in-law is a Home Economist at local high school.

I was chosen to be a Heart of FCE candidate in 2005 and then chosen as the state heart winner, a very worthy honor that you never think can be yours. By the will of God and God's gift to me of these years' a special thanks for being an FCE Member.

Tree of Knowledge

Whenever we study our past, it is always fun to uncover what we didn't know or have long since forgotten. We've previously discussed that the roots of FCE are in Tomato Clubs, Home Demonstration Clubs, Extension Homemakers, 4-H, Cooperative Extension, and USDA.

National FCE was established in 1936. It is evident that throughout our organizational metamorphoses, the basic objectives have remained constant as we also seek to strengthen individuals, families and communities through continuing education, developing leadership and community action. Our special opportunity to develop leaders is the focus of the Tree of Knowledge Scholarship program. This year we will award the first four scholarships of the Tree of Knowledge program. On April 15, two names of nominees will be drawn to attend National FCL training in Portland on July 15 with a registration scholarship. During NAFCE conference in Portland, two more names will be drawn for National FCL training in 2010.

Participation in this developing leaders program is easy and cost effective. The Tree of Knowledge is in need of leaves. Each leaf costs \$5 and entitles the donor to name a possible recipient, either by name, state or region. There are three basic levels of participation. A Green Leaf sponsorship is \$5 for one leaf of opportunity to name a possible recipient under the age of 41. A Silver Leaf sponsorship is \$25 for 5 leaves of opportunity. A Gold Leaf sponsorship is \$50 for 10 leaves of opportunity. This program is one in which everyone on every level can participate. The first \$340 was raised when the Tree was introduced at National convention in 2008. Missouri and Arizona raised \$35 and \$50 respectively at their state conventions. Therefore our current scholarship fund has \$425 available for use this year. At convention in Portland, everyone will have an opportunity to continue and expand the scholarship program for our future leaders. You also may send in contributions to the National Treasurer at any time.
