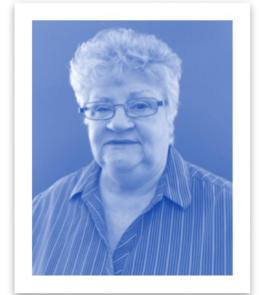

KAFCE STATE PRESIDENT - NANCY KERNICK'S REPORT – “NETWORKING WITH NANCY”



As we ended the year of 2021, I want to thank you for your perseverance, provide KAFCE updates, and preview upcoming discussions on the strategic goals. In January 2020, just after I assumed the duties KAFCE President, I read an article titled: “Change Brings Opportunity.” At that time, we were just beginning to learn of COVID cases in the United States. I could not imagine the change just around the corner. If I had, I would have titled that article: “Challenges Bring Opportunity.” Since then, our experience has shown us that yes, indeed, recent challenges brought opportunity and I applauded the response of members of our KAFCE to various challenges 2020 brought. We embraced opportunities and the period of rapid change was mostly behind us and our challenge at that time was to determine how to assimilate our best adaptations into our pre-COVID practices and I naively thought, as did many others, that we were nearing the end of COVID’s disruption.

As I write this, we continue to adapt and confront challenges. And, we still find opportunities to improve our KAFCE. We continue to re-engineer both remote and in-person procedures and to implement other programs to help ensure our neighbors have safe access to fair and impartial information. Looking back over the last nineteen (19) months, I am extremely proud to be a member of KAFCE. Our collective responses have been to harness bold ideas, implement thoughtful solutions, and adopt a spirit of perseverance that moved our KAFCE forward. We have proven that change could bring positive and enduring benefits.

By doing so, we have made progress toward the KAFCE “Mission Statement” which is “To strengthen individuals and families through: (1) Continuing Education; (2) Leadership Development; and (3) Community Service.” Through innovation, the KAFCE has increased its use of technology for processing matters of education and leadership. New web portals allow KAFCE and interpreters to use remote technology to supply services to many of our members, who face barriers to access. All of us have incorporated remote proceedings into our toolboxes. K-State continues to encourage remote meetings when possible as we work to be efficient and safe. Remote meetings do not fit well for some, and some circumstances; but for many proceedings, we have found that remote meetings offer benefits beyond safety to others. Proceedings can improve because a remote meeting supplies ease of access and lower costs for the parties through time and cost savings. We are working diligently to adopt a mindset of continuously looking for ways to improve access for all through the use of technology.

I also want to applaud your efforts in assisting the officers in safely resuming meetings which have presented challenges from the onset of the pandemic. K-State, with assistance from members of KAFCE, implemented that guidance, overcoming virus-related obstacles to safely convene having meeting in your communities. There is much work ahead in this area, and I am grateful for your dedication to maintaining the integrity of KAFCE.

KAFCE has 587 members including 59 Independent Members

- Total paid membership for 2022 is 593 minus six deaths leave active membership of 587.
- We lost twelve FCE Units, and 95 members from 2021, due to moving, death, and aging.
- There are 41 counties with FCE members and 58 FCE Units, and 59 Independent Members.
- Twenty-three (23) new members joined this year, plus eight (8) members re-joined.
- Ten (10) counties had an increase of at least one (1) member and they are NE-Doniphan, SW-Finney, NW-Phillips, NW-Rooks, SC-Saline and SW-Wichita.
