Each student receives a \$1000 Scholarship that is given to them in the spring for use that fall. The students apply for the Scholarship and the UNL Foundation handles all the necessary details. The school then sends information to the Benefactors about the Luncheon and after receiving reservations notifies the students to also invite them to attend.

In the 2021-2022 school year there were 3 scholarships awarded and 2 in the 2021-2022 year. The Scholarships come from the interest earned from an account that was set up many years ago. Only the interest can be used to make this a perpetual account to benefit Homemaker and Education students.

The information about the Luncheon usually comes after we hold our Annual State Conference. This year, a “Save the Date” invitation was sent early, and I received it in June. We will get more information before long since the Luncheon Date is set for September 30 and it will be held at the University of Nebraska East Union. own reservations by calling the Hotel directly at 402-753-3850 and mentioning that you are with the “Nebraska State FCE Convention being held September 22 – 24”. Breakfast each day is included in the price of the room. The room price would also be good if you want to come on Wednesday so as to be there to go on the Tour Thursday.

You may always stay at another motel/hotel or even drive every day if it is more convenient for you. A block of rooms is reserved so we can all be together for sharing time and pooling rides.

The Conference and Business meeting will be held at Peace Lutheran Church which is east of Fremont. Follow Highway 30 or the by-pass around Fremont to the east side of town and then head east.
